Reference is invited to Food Safety and Standards Authority of India's Order dated 04.04.2025 issued from File No. QA-12012/141/2021-QA-FSSAI (copy attached), on the above subject.

- 2. As stated in the said Order dated 04.04.2025, a Memorandum of Understanding (MoU) has been signed between the Food Safety and Standards Authority of India (FSSAI) and the Department of Food Technology and Quality Control (DFTQC), Nepal, for cooperation in the field of food safety. - 4. The analysis certificates issued by NFFRL, Kathmandu, Nepal, for the following food products shall be accepted by the relevant authorities in India dealing with food imports.
 - (i). Juice
 - (ii). Jam
 - (iii). Jelly
 - (iv). Pickles
 - (v). Candies
 - (vi). Ginger
 - (vii). Fresh fruits and Vegetables
 - (viii). Instant noodles.
